### Doctoral Study by Jill Forte

Jill Forte, a doctoral student at Indiana Wesleyan, reached out to INPEA to gain assistance in participation from our member schools. As fellow educators, please watch for her email survey, and if at all possible, assist her in her research. See the description below from Jill:

- My name is Jill Forte, and I am a doctoral student at Indiana Wesleyan University studying educational leadership in our state. The current reforms in education at the Indiana state level create a unique environment from which other states and nations can learn. At issue is what style of leadership our principals utilize in the current environment and how that style, in this environment, influences teacher commitment to the school. I am conducting a research study in November 2014 that will use two survey tools to measure principal leadership style and teacher organizational commitment. I am surveying 82 schools across the state, and the data will be aggregated. I will be asking principals to enter at least ten teacher emails to the survey company, Mind Garden, for confidentiality. The surveys should take less than 25 minutes to complete. Further, the data will be submitted directly to Mind Garden, which will provide it to me in total. Principals can obtain a copy of a report on their leadership style from Mind Garden (with at least ten teacher respondents-a \$100 value), and teachers can enter into a drawing for a Visa gift card (one per school). Even more significantly, this is an opportunity for Indiana principals and teachers to be heard. Thank you for your support

Does your school have a legislative liaison? It should! It is critical that Indiana's non-public schools are prepared to engage legislatively in support of schools and the

many students who attend them now and in the future. Legislative Liaisons are INPEA's grassroots network. We anticipate that the 2015 General Assembly session will be a difficult one. It is important that we have structures in place so that the non-public schools voice be heard.

## Preschool Pilot

Schools in 4 of the 5 pilot counties (not Jackson) will be able to apply to be approved as providers in November.

Remember the first criteria for participation is:

- Either
  - Preschool is nationally accredited by NAEYC or ACSI
  - Preschool has met the State's Paths to Quality criteria for Level 3 or 4
- The school's preschool program has been accredited by 1 of the 8 accrediting bodies approved by the State Board of Education (same entities approved for the voucher program). Preschool must have been included in the accreditation protocol.
