### Every Student Succeeds Act

After 13 years, ESEA was finally reauthorized and renamed ESSA by the US Congress. There are a number of improvements for non-public schools in the new law. Unfortunately, we will not see evidence of those changes until the 2017-18. A few of the big wins include: non-public schools allocation must now come off the top rather than after all set asides. This should increase our share and services. Also, the state will be required to appoint an ombudsman to help arbitrate concerns with how the programs are being implemented in non-public schools.

## School Scholarship Tax Credit Cap Reached

The Scholarship Tax Credit (SGO) Program had a slow start when it was passed into law back in 2009. This philanthropic best kept secret is a secret no more, as evidenced by donations reaching the statewide cap two years in a row. As you know this program allow donors to donate to an approved 501c3s (SGOs) and receive a 50% tax "credit" off their state tax liability. This program is particularly important to voucher schools because it is also a pathway into the voucher program.

This year's statewide tax cap was \$8.5 million dollars. **On February 9th, 2016 the School Scholarship Tax Credit cap had been reached. No more tax credits will be issued for this fiscal year ending June 30th, 2016. On July 1st, the new fiscal year amount of \$9.5 million will be available.**

### Legislative Update

#### Senate Bill 334

SB 334 passed the House Education Committee Thursday morning (Feb. 25) with an 8-4 vote. Many amendments were attempted to be added to the bill.

An amendment to make the bill solely for dropouts failed 8-4 as well. After passing out of the Senate with bipartisan support, there were concerns it might not make it out of committee on the House side.

SB 334 is a Choice Scholarships bill which would provide some much needed and desired improvements to the Choice Scholarship Program. The bill addresses the need for students to have two application windows into the program, therefore allowing students to transfer in the second semester. Additionally, the bill would only require parents to sign a designation form once a year, rather than twice a year which would free up unnecessary paperwork and ease the strain on schools and parents.

Republicans have amended SB334 with somewhat unrelated issues which are important to all sides to gain broader support for the bill. In the House Ed committee an amendment dealing with background checks and confidentiality agreements was added to the bill. The Bill now moves to the Ways and means committee where it could be further amended.

It is critical to the Choice Scholarship Program for this bill to succeed. Please tell your House representative to support Senate Bill 334! Every voice counts!

### **Senate Bill 93**

From our legislative update: "SB 93 is a very arduous education bill with many factors. The original bill included a limit on school transportation by a public school for nonpublic school students by limiting the pickup and drop off points to the regularly established route. Multiple safety concerns were address by many in committee testimonies. Though testimony and meetings with the Sen. Kruse, the author of SB 93, the provision was amended out."

### **House Bill 1002**

From our legislative update: "HB 1002 would create a next generation Hoosier educators scholarship. The Commission for Higher Education would be able to award scholarships for up to \$7,500 each academic year for four years. HB 1002 could help entice future students into studying to become an educator, and reduce the financial strain on those recent graduates. HB 1002 may also help to reduce the teacher shortage and aid the workforce. These scholarships would be available to high performing students willing to commit to teach 5 years in a public or choice school."

**UPDATE: This bill was amended in the Senate Appropriations Committee to have the Higher Education Commission study the issue instead of initiating a program at this time.**

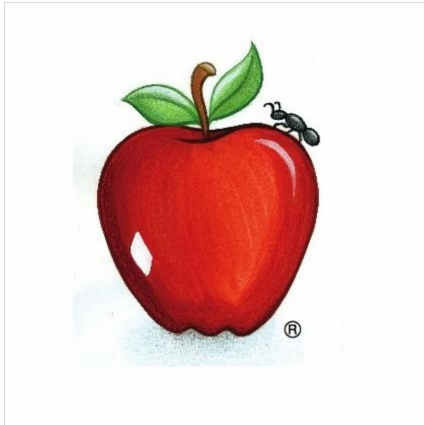
